**INSTRUCTIONS TO THE CANDIDATES**

- Carrying the **Admit Card** during examination is mandatory. Entry shall not be permitted without Admit Card.
- Only Blue/Black colour pen should be used for writing the examination.
- Entry to the examination hall will not be permitted 15 minutes after the start of examination. Exit from the hall will not be permitted 15 minutes before the end of examination. Candidates who wish to leave the hall before 30 minutes prior to the end of examination must submit the question paper to the invigilator.
- All candidates shall produce valid Institute ID Card as and when instructed by the invigilator or members of the vigilance squad or other officials of the Institute.
- Candidate should be seated in the exam hall as per their Registration no. Candidates are not permitted to bring any loose written or blank sheets other than those permitted by the course faculty to the examination hall. **Any code books / data handbooks/ other handouts carried by the candidates shall be duly attested / endorsed by the course faculty.** Any additional scribing in such materials with pen or pencil will be treated as attempts for exam malpractice.
- Mobile phones/ Smart watches / Bluetooth devices/ similar electronic gadgets are strictly banned in examination halls.** Carrying such devices to the exam hall will be treated as attempts for exam malpractice.
- Immediately after the question papers are issued to the candidates, the candidates should write their name and Roll No. on the question paper. **It is also instructed that no other pen/ pencil special markings are to be made by the candidate in the question paper and Answer Booklet.**
