Remuneration and Terms of Engagement:

1. The Guest faculty shall be paid a consolidated fixed remuneration amount of Rs. 2,000/- (Rupees Two Thousand only) per lecture/practical class with a maximum capping of Rs. 64,000/- (Rupees Sixty Four Thousand only) per month.
2. No TA/DA shall be provided over and above the fixed remuneration.
3. The engagement of Guest Faculty will be purely temporary for the odd semester, Academic Year 2026-27 or till December 31st, 2026 whichever is later. It may further be extended as per the requirement of the Institute and performance of candidate, as per the Institute rule.
4. The engagement/position does not confer any right on the candidate to claim either continuous employment or permanency in the future.
5. The engagement may be terminated at any time by either side by giving one month notice.

Mode of Selection: INTERVIEW

1. The initial screening/short listing of the candidates for engagement as guest faculty shall be done as per the prescribed qualifications.
2. The shortlisted candidates will be required to appear for document verification and/or Interview.
3. Final selection will be made on the recommendation of selection committee based on the performance of candidate in Interview.

Note: In case of large number of applications, the institute may use suitable criteria for short listing to limit the number of candidates for Interview.
