- Scanned copy of only the duly filled and signed Application Form may be emailed in advance to recruitment@niamt.ac.in with copy to hodece@niamt.ac.in **before one week of the date of Interview to be notified later on the Institute Website.** Scanned copies of any other document and certificates should not be sent to the institute.
- Based on the credential mentioned in the application form and depending on the number of application forms received, the Institute may fix a higher criterion for restricting the number of applicants to appear in the Interview.
- Any candidate who fails to submit application by email within the stipulated date may, at the discretion of the Selection Committee, permitted to appear in the Walk-in-Interview, subject to fulfilling the eligibility criteria mentioned in the Advertisement and/or any higher criteria as may be fixed for this purpose.
- Bring the filled in original Application Form alongwith all the required supporting documents regarding educational qualifications, experience, date of birth, etc. in Original, and one set of self-attested photocopies of these documents. Also bring a valid Government Id (for the proof of your identity) on the date of the walk-in-interview.

3. General Information:

- Institute reserves the right to cancel the recruitment process at any time. Institute may increase or decrease the number of vacancies or not select any candidates without assigning any reason.
- Appointment will be given initially for 11 months and may be extended based on Institute requirement and candidate's performance.
- The recruitment is purely on a temporary basis and the candidate appointed shall have no claim for a regular appointment.
- The contract may be terminated at any time by either side by giving one month notice to the other side.

The Offer of Appointment to the selected candidates for the post of Assistant Professor on Contract purely on Temporary Basis will be provisional and subject to verification of the original documents at the time of joining. The offer of Appointment will be cancelled automatically on failure to join on time and/or on detection of any misleading information provided by the candidate in the application form for which supporting document(s) is/are not produced.
- f. No TA/DA will be paid for attending the Walk-in-Interview and candidates have made their own arrangement for a stay.
- g. **Date of Walk-in-Interview will be Scheduled tentatively on any date in 2nd week or 3rd week of July 2025.** Exact dates will be notified on the Institute website.
- h. Candidates are advised to visit the Institute website regularly for updates. No individual communication will be sent to any candidates.
- i. The Institute reserves the right to amend and implement any other criteria for the selection or shortlisting process at any time of the selection process. Institute decision will be final in this regard.
- j. In case of reporting of large number of applicants, the institute may use suitable criteria for shortlisting to limit the number of candidates for Interview. Criteria may be MCQ based Written Test and/or evaluation of the Educational Qualifications and/ Publications.
