CIRCULAR

Sub: - Guidelines / Measures for containing spread of COVID-19 infection in the campus.

In continuation of earlier circulars and in consideration of rising instances of spread of COVID-19 (Omicron variant) in the state and Order issued by Chief Secretary, Department of Home, Jail & Disaster Management, Govt. of Jharkhand (Disaster Management Division) dated 03.01.2022 for containment of COVID-19 cases, following measures / guidelines are issued: -

- RT-PCR test will be conducted compulsorily for all students (A.D.C. / B.Tech. / M.Tech. / Ph.D.)
 who are in the campus presently. The cost will be borne by the Institute out of IRG Fund. [Action:
 SMO & Chief Hostel Warden]
- 2. Those students who are tested COVID Positive will be put in Isolation for Seven (07) days in NIRALA HOSTEL immediately. Necessary arrangements with respect to food and other supplies be arranged accordingly. Necessary security arrangements to be ensured at all times to keep the students tested positive to complete their Isolation in Nirala Hostel. [Action: SMO, Chief Hostel Warden, Chairman S.M.C.]
- 3. All students who tested COVID Negative must vacate the hostel by 08.01.2022 (Saturday) midnight. [Action: Dean (S & A) & Chief Hostel Warden]
- 4. All the students [ADC / B.Tech. / M.Tech. / Ph.D.] who are at home must remain at home and are not permitted to come back to the Institute. Entry of all students in the campus from outside is strictly prohibited. [Action: Dean (S & A) & Chief Hostel Warden]
- 5. RT-PCR test of all staff (permanent or contractual) will be conducted. The cost of which will be borne by the Institute out of OH-31 Fund. Those tested COVID Positive should be in home isolation / NIAMT Niwas for Seven (07) days and will be allowed to work from home. [Action: SMO &
