Tech.
- III. Since shortlisting criteria were elevated to Ph.D. vide notification dated 25/02/2021, the benefit of award of Ph.D. degree till 25/02/2021 as per the note under shortlisting criteria (a) mentioned in the notice was considered for shortlisting of those candidates who have done their M. Tech degree in any of relevant fields mentioned in the advertisement.
